This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

Lead exposure has been associated with increased risk of lung, stomach, and bladder cancer in diverse human populations. In studies of humans occupationally exposed to lead, there is evidence to suggest that lead damages chromosomes or DNA. In most studies, lead caused micronucleus formation, chromosomal aberrations, and DNA damage, but studies on sister chromatid exchange gave conflicting results. Genetic studies on humans environmentally exposed to lead also gave conflicting results. Lead did not cause mutations in bacteria, and results from test systems using mammalian cells were conflicting.
