This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:

Inhalation: First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor. **Skin Contact:** Quickly and gently brush away excess particles. Wash gently and thoroughly with warm water (use non-abrasive soap if necessary) for 10-20 minutes or until product is removed. Under running water, remove contaminated clothing, shoes and leather goods (e.g. watchbands and belts) and completely decontaminate them before reuse or discard.

Eye Contact: Quickly and gently brush particles from eyes. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed, while holding the eyelid(s) open. Obtain medical advice immediately if irritation occurs. Take special care if exposed person is wearing contact lenses. **Ingestion:** If swallowed, do NOT induce vomiting. Wash mouth with water and contact a Poisons Information Centre, or call a doctor.

Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. Section 10 - Stability and Reactivity

Nickel metal is Classed by SWA as a potential sensitiser by skin contact.

Prolonged or repeated contact with material may result in skin irritation leading to dermatitis. Skin contact with the metallic nickel powder may result in sensitisation and nickel contact dermatitis ('nickel itch').

Nickel compounds are known to be human carcinogens based on sufficient evidence of carcinogenicity from studies in humans, including epidemiological and mechanistic information, which indicates a causal relationship between exposure to nickel compounds and human cancer. The findings of increased risk of cancer in exposed workers are supported by evidence from experimental animals that shows that exposure to an assortment of nickel compounds by multiple routes causes malignant tumours to form at various sites in multiple species of experimental animals. Skin Contact:

Short Term Exposure: May dry and defat the skin, resulting in skin irritation and possible dermatitis. Grease accidentally injected under the skin can result in local necrosis and tissue damage. Nickel is classified as a sensitiser. Repeated/prolonged exposure may result in sensitisation. Once sensitised, further exposure may result in allergic reactions which in some cases can be severe.

Long Term Exposure: No data for health effects associated with long term skin exposure.

Short Term Exposure: This product is believed to be mildly irritating, to eyes, but is unlikely to cause anything more than mild transient discomfort.
